### Terms and Conditions

- An entry fee of \$10 per truck is payable at Show Office (Eftpos or cash). The Show Office is in the sealed area, on the Corner of Gould Ave and Deans Ave, near the Curlett Road Entrance.
- Please use the Show and Shine Multiple Entry Form if entering more than one truck and an invoice can be issued.
- Show and Shine registration, event number, and information are available at the Show Office.
- All traffic management rules and signs must be obeyed in and around Canterbury Agricultural Park.
- Entry time options to the park are:
  - Friday 7th March between 5 pm - 7 pm.
  - Saturday 8th March between 5.30 am to 8 am.
- All trucks must be parked and stationery by 8 am, **NO EXCEPTIONS**
- HI-Vis to be worn except when open to the public
- Show and Shine trucks enter through the truck entry via the onramp, located behind the stockyards, and will be directed where to drive/park.
- Trucks will have lights on, and travel no faster than 10km/ph. Please move with extreme caution.
- Parking of the trucks: Please follow the directions of the Show parking staff.
- Please remove your vehicle keys once parked.
- Children must be supervised and under control at all times.
- The organisers accept no responsibility for incidents caused by inadequate supervision.
- Gates are open to the public on Saturday 8th March 2025 at 9 am. No movement of any vehicles is allowed during the show from 9 am to 5 pm unless requested or approved by show officials.
- Sausage sizzle driver's breakfast will be available in the NZ Trucking Association area near the Show Office from 7 am to 8 am on Saturday 8th March.
- Trucks **MUST NOT** move or leave before 4.30 pm on Saturday 8th March.
- BBQs or any form of cooking is not permitted.
- Alcohol is not permitted at any time, including pack-in or public opening hours - unless authorised by the Show Organisers.
- Alcohol will be available for purchase at specified events
- There is to be **NO SMOKING** inside any Marquees, or Showgrounds buildings.
